MESSAGE FROM THE CHAIR

I am pleased to report to our members that Disability Sports Australia (DSA) had another very successful year to June 2022. This is a credit to our team led by CEO, Murray Elbourn, our supporters and sponsors and the DSA Board Directors.

Success can be measured in the number of events delivered, the number of people with disability who had the chance to participate in sports and activities and the strong financial position that has been achieved. The success of all these areas means that DSA has continued momentum heading into the new year.

The careful management of our resources through the "Covid Era" and the planning of new areas for DSA to be involved in, has seen a year full of activities, with new programs delivered, more opportunities for people with disability and the diversification of our revenue streams.

This Annual Report will detail many of the activities of DSA, I would like to draw your attention to 2 areas that were delivered or enhanced through the year.

The NDSP National Referral Hub is an innovative online service that has been delivered through the championing of the CEO. It is a first in the Australian community that brings the NDIS partners, sporting organisations and people with disability together to deliver much improved sporting and participation outcomes. It has been rewarding to see the support from our partners to this program and will continue to see further services added over the years.

DSA has been active in the formation and managing of many sports, with the goal to ensure they are adapted for people with disability and are sustainable, we call it our Sports Incubator. It has been very gratifying to see the development of Wheelchair Rugby in Australia to the point of it becoming a stand-alone sport, Wheelchair Rugby Australia. The Australian wheelchair rugby team, the Steelers, have enjoyed great success over many years, and now with the incredible efforts of Chris Nay, and DSA, the sport is moving to an independent future in an extremely strong position.

There is a real momentum in the community around sport for people with disability and DSA has played an active role in the continued development of an alliance of sports called the Australian Sporting Alliance for People with a Disability (ASAPD). All nine members are working to improve inclusion, participation in sport and physical activity for the nearly 20% of Australians with disability.

This is my last report as Chair of DSA, it has been such a rewarding experience. There have been many highlights with the World Wheelchair Rugby Championships, the development of the Sports Incubator and the delight of kids being given their chance to try an array of sports. There have been tough times as well, with very difficult financial circumstances and the navigation of the Covid era. Through the ups and downs, I have had the opportunity to work with an exceptional group of people, both management and Directors and this has made the journey most rewarding. I feel confident that DSA is in great shape and will continue to deliver amazing outcomes into the future.

MESSAGE FROM THE CEO

As CEO of Disability Sports Australia, I am pleased to report another strong financial year for our organisation, coming out of the Covid pandemic. This period has allowed our organisation to focus on building strong deliverable programs which centre around our NDSP National Referral Hub.

As events have been able to be re-established, our team has successfully delivered both the 2022 Wheelchair Rugby Australian Championships and our first Disability Sports Australia national conference in partnership with Sunshine Coast Council and University of the Sunshine Coast. These events have provided our organisation with increased partnerships, media and inter sector opportunities to collaborate.

DSA also led a \$30.5 Million dollar bid in collaboration with Blacktown City Council to establish Australia's first dedicated Disability Sports Centre of Excellence from the NSW Office of Sport grant. Within the bid, DSA collaborated with the Para sports of Badminton, Boccia, Fencing, Goalball, Judo, Taekwondo and Volleyball. This project due to be completed in December 2024, will enable these seven sports to fast track their paralympic programs with the assistance of DSA's Sport Incubation program and further be supported by cotenants Australian Catholic University and Western Sydney Health district. This is a ground-breaking project for disability sport in both NSW and Australia.

Following on from two previous years of successful growth and program delivery, our organisation has been able to reinvest in adding crucial staff at senior management level to further extend our capability to support our mission and vision. Our organisation has added key resources in finance, data systems, commercial, operations and governance to support the increased work from collaboration. I am pleased to welcome all of our new staff, who join an existing group of impressive employees who have delivered consistently through the growth of our organisation.

As always, we couldn't have had this success without our major partners, I would sincerely like to thank all our major partners being:

Australian Sports Commission, Northern Territory Government, Santos, NDSP Plan Managers, GIO, Lifestyle Solutions, Degnan, Coloplast, PCYC, Belgravia Leisure, Sport NSW, Variety – The Children's Charity, Mable, Playgroups NSW and The Levick Family Estate.

I would also like to thank our National Referral Hub Councils and Preferred Partners who have supported our vision for referrals to community to enable all Australians to be more active, more often.

Finally, I must thank all of our state and territory member organisations, as we move into large projects like the National Integrity Framework, it is imperative that DSA communicates and collaborates with our member organisations to deliver strong outcomes for participants.

ACTIVATE INCLUSION SPORTS DAYS (AISD)

Our Activate Inclusion Sports Days (AISD), which provide the opportunity for children with disability to try multiple sports in a fun, safe and inclusive environment launched nationally in 2022. Launching the program across the country saw us deliver 54 events, with over 5000 children attending.

Delivering AISD in new locations has given children the opportunity to participate in sports who may otherwise have missed out and whilst we always knew what a huge impact our events can have, the feedback we have received this year has blown us away!

SPORTS INCUBATOR

DSA aims to increase the range of sport and active recreation opportunities for all Australians with disability. Ensuring sustainable and effective inclusive and adaptive sport development is at the core of DSA's operations and the Disability Sports Incubator has continued to develop and grow to be the premier program assisting mainstream sports to develop their inclusive offerings.

Through further research and consultation with national sporting organisations, it was clear that further education, awareness and opportunities were required by mainstream sport to sustainably deliver inclusive and adaptive programs. DSA took this advice on board and re-worked the Disability Sports Incubator model to better create a stronger inclusive and adaptive Australian sporting landscape with increased participation and broader pathways.

The Disability Sports Incubator provides NSO's the skills and opportunities to effectively and efficiently develop and implement their inclusive and adaptive sporting goals in partnership with Australia's national peak sporting body for people with disability.

Disability Sports Australia thanks the Australian Sports Commission for their ongoing support of this program.

SPORT & RECREATION PROGRAMS & DEVELOPMENT

Frame Running

Frame Running (formerly Race Running) continued to go from strength to strength in 2021/22. Local club development and participation has increased immensely.

Frame Running programs and initiatives are now being rolled out in each state and territory with opportunities to access equipment being provided.

The partnership with Athletics Australia has proven to be beneficial as internationally CPISRA continues to work with World Para Athletics. Athletics Australia has taken significant steps to integrate Frame Running into its classification and events. DSA and Athletics Australia will continue to work together in a formal capacity to develop the sport across the country.

DSA look forward to celebrating the first ever Australiasian Camp and Cup in Queensland hosted by Dejay Medical in September 2022.

Wheelchair Aussie Rules

Despite the impact of COVID-19 on national competition, state and local development of Wheelchair Aussie Rules has proved to be an outstanding success.

Unfortunately, both the 2020 and 2021 Wheelchair Aussie Rules National Championships were cancelled due to COVID-19.

however the 2022 Championship is due to go ahead in November.

Established programs in South
Australia (lead by South Australia
National Football League), Tasmania
(led by member organisation, ParaQuad
Tasmania) and Victoria (led by AFL
Victoria) continued to grow with South
Australia running the very first state league,
the Novita SANFL Wheelchair Football League.
The established states player pathways provide
significant player funnels to interstate and national

competitions.

New South Wales continued to develop their state program after a strong start in 2019. Wheelchair Aussie Rules programs were also started in Western Australia and Northern Territory. NSW, WA and NT are all looking to be represented at the next National Championship. Come and try events are planned for Queensland in the next 12 months. This would bring a full national presence to the sport.

DSA continues to work closely with the Australian Football League (AFL) to partner and grow the sport nationally and increase the public profile of the sport. The Australian Defence Force (ADF) continues to champion the sport and the significant impact it has on the rehabilitation of current and ex-servicemen and women.

In the face of two cancelled National Championships, the next Nationals are looking to be the largest Championships on record with ten (10) team representation in 2 different divisions providing an invaluable opportunity to profile the sport to the wider Australian audience and get more people involved with the sport at a grassroots level.

CREATE MORE CHOICE

DISABILITY SPORTS NORTHERN TERRITORY



Since the establishment of the branch in 2019, Disability Sports Northern Territory (DSNT) has been able to get more people with disability across the Northern Territory more active more often. The financial year of 2021/2022 saw a steady development of pathways and programs supported by James Little, as well as a shift in staff with Jacinta de Niese coming into the Sport

Coordinator role in April of 2022 continuing the development of DSNT's reach.

A key area of growth has been within sector engagement, via increased brand identity and awareness. An Instagram account was created in May 2022, gaining over 100 followers in its first month of engagement. Increasing presence on social media has helped to increase participation at local events and build relationships with members of the community, such the Being Mentors group. Stakeholder relationships have been re-established since April 2022, by actively connecting with Peak Sporting Bodies and facilitating the delivery of Come N Try events. DSNT was privileged to co-host Dylan Alcott in Darwin with Tennis NT and Somerville Community Services, where local students were given the chance to meet our Australian of the Year, hold his most recent Gold medal and have a hit on court with him. In addition, DSNT partnered with AFL NT to run a Wheelchair Football Come N Try clinic with the Gold Coast Suns Football Club. Social media posts from these events gained lots of traction, being shared by the likes of Dylan Alcott and the Gold Suns FC. DSNT has also supported local events such as the Be Inclusive Games program delivered by Clubhouse Territory.

DISABILITY SPORTS NORTHERN TERRITORY

In partnership with Total Recreation, Variety Children's Charity – NT and Disability Sports Australia, Activate Inclusion Sports Days are now a fixed calendar event for Darwin. A total of roughly 90 students attended the first AISD for 2022, which was held in June. They participated in a mixture of inclusive sports delivered by Golf NT, Wheelchair Rugby League, Topend Zumba Crew, NT Cricket, Touch Football NT and Blind Sports Australia. Students from Charles Darwin University and SEDA College attended the event and supported the delivery of adaptive recreational activities by building rapport with the students and learning from the Peak Sporting Bodies present. DSNT is excited to deliver two more AISDs in Darwin for 2022, as well one returning to Alice Springs to repeat the success of last year and bringing the program to Katherine for the first time.

DSNT would like to thank the sponsors and partners who make providing sporting opportunities to Territorians with disability possible. DSNT would like to thank the Northern Territory Government for their ongoing contribution and support, Total Recreation for the continual cross-collaboration, Variety Children's Charity – NT for supporting Activate Inclusion Sports Days and all PSBs that have dedicated time and resources to increase opportunities for Territorians with a physical disability. AS DSNT looks to the future, the focus will be on increasing brand awareness, building partnerships with key stakeholders in the Territory and supporting regional areas to access inclusive sport opportunities. DSNT will continue to break down barriers to participation, helping to aid Territorians in access to sport equipment and programs.

DISABILITY SPORTS AUSTRALIA NATIONAL CONFERENCE 2022

The Sunshine Coast Sports Symposium and DSA National Conference (the Conference) was held from Wednesday, 15 – Friday, 17 June 2022 at USC Stadium. The Conference was held in partnership with Sunshine Coast Regional Council and the University of the Sunshine Coast.

The three day event was headlined by the inaugural DSA National Conference. The theme for the Conference was: Runway to Brisbane 2032: Maximising collaborative participation for people with disabilities in sport on the pathway to Brisbane 2032.

Key highlights from the event included:

- Keynote address from newly appointed Australian Sports Commission CEO, Kieren Perkins OAM
- Attendees from across sport, government, education, allied health, disability and support services
- Successful delivery of hybrid model conference
- Positive feedback on content delivered
- Opportunity for networking beyond the conference

A total of 199 people purchased tickets and attended across the three day, both in person or online. Of this, 113 were from QLD while the remaining 86 were from the outside of the state.

While the stream was hidden from the main public, it received in total across the three breakout sessions and keynotes, 274 unique views with a total of 6,129 minutes watched.

A feedback survey was distributed after the event. The overall feedback on the event was extremely positive. Key takeaways from this feedback included:

• Overall average rating for the event being 8.1 out of 10 with 1 being unacceptable and 10 being outstanding.

 The quality and variety of speakers as well as the relevance and usefulness of the topics being covered were highlighted at the key positives from the Conference

 Participants provided a range of responses for areas to focus on for future conference and events, including: NDIS access, pathways structures, focus on program development for adults and practical, actionable steps for organisations to be more inclusive.

The 2022 Santos Wheelchair Rugby National Championship was held from Friday 24 – Sunday 26 June 2022 at the Gold Coast Sport & Leisure Centre in Carrara. The event returned to the Gold Coast for a second year after the success of the 2021 Nationals.

The event was the most successful National Championship in history on a number of fronts. Both Division 1 and Division 2 had 4 competitive teams, the most teams to participate in a National Championship with the greatest number of athletes participating.

The number of domestic teams competing at the Championship rose from six (6) at the 2021 event to seven (7) in 2022, with the return of the New Zealand Wheel Blacks after not being able to attend due to COVID-19.

The event was broadcast through Foxtel and Kayo Sports. The entire event was streamed live and free on Kayo Freebies with Saturday and Sunday's matches being broadcast on Fox Sports 505 and 507 respectively, providing a larger national platform for the sport than previously been seen.

The 2022 Nationals proved to be a great success and Wheelchair Rugby Australia are looking forward to the growth of the event in 2023.

WHEELCHAIR RUGBY AUSTRALIA

2022 NATIONAL LEAGUE



2022 saw the return of the new look Wheelchair Rugby National League. The National League saw the establishment of six (6) new wheelchair rugby franchises with players being drafted into teams and competing across three rounds of competition between February and May in 2022.

Melbourne Rugby Club (VIC), Box Hill Rugby Club (VIC), University of QLD Rugby Club (QLD), Brother Rugby Club (QLD), Sydney University Rugby Club (NSW) and Tuggeranong Vikings Rugby Club (ACT) drafted over 60 players from across the country for the three-tournament league. The new model placed wheelchair rugby on the mainstream stage through partnerships with elite level rugby clubs across the country, allowing for fan bases, team colours, uniform alignments and media exposure to be developed.

The was an incredibly successful competition with increased player engagement and quality gametime for domestic athletes through the creation of a genuine player representative pathway.

Special thanks to the Rugby Club Foundation for their support of the Wheelchair Rugby National League, as well as to Disability Recreation & Sport (VIC), Sporting Wheelies & Disable Association (QLD) and Wheelchair Sports NSW/ACT (NSW/ACT) for their management of the National League teams and delivery of the tournaments.

PATHWAYS, PARTICIPATION AND DEVELOPMENT

This year saw consistent competition and pathways since the start of the COVID-19 pandemic. After two and half years of inconsistent competition, the pathway through recruitment, local competition, National League and National Championship was successful in the lead up to the 2022 World Championship in Denmark. In collaboration with Paralympics Australia, new athletes were recruited into state programs, increasing participation rates and the ability for quality competition.

Similar to 2021, WRA offered support to the South Australian Sharks team for the National Championship, covering uniform costs and staff travel expenses for the team to compete, along with arranging staff and logistical considerations in support of the Australian Barbarians.

Wheelchair Rugby Australia would like to take this time to thank the state/territory programs for all their valued participation and collaboration on a number of items in the past twelve (12) months. The sport of wheelchair rugby is more aligned at present than it has been before.



WHEELCHAIR RUGBY AUSTRALIA

Coach and Referee Development

Wheelchair Rugby Australia in partnership with Paralympics Australia and Rugby Australia released a Wheelchair Rugby Foundations and Level One Coaching Course via Rugby Xplorer. The learning modules were launched at the start of 2022 and allows all new and existing wheelchair rugby coaches and officials to be education of the foundations of the sport. Additionally, through hosting on the Rugby Xplorer platform, it allows for prospective officials and coaches to find more quality information and pathways for wheelchair rugby.

Referee recruitment and education continues to grow. Without the COVID-19 restrictions, education sessions and evaluations were able to be conducted at the National Championship in June with new referees given the opportunity to officiate at the highest domestic level in Division 2.

WRA looks forward to the continued growth and development of officials and coaches in the coming year.

Launching in October 2021 in partnership with NDSP Plan Managers, the NRH will be a simple and efficient platform for

individuals, healthcare providers, teachers and parents to find activities and programs in their local areas. Providers of sport and active recreation programs will be able to be added to the national database and accessed by all Australians with disability.

Working closely through established partnerships with the Australian Physiotherapy Association, Occupational Therapists Australia, Sport Medicine Australia and Exercise Sport Science Australia, the NRH will ensure that even the most complex of enquiries can be managed expertly.

Disability Sports Australia thanks NDSP Plan Managers for the invaluable support of the NRH and look forward to being able to connect even more Australians with disability to sport and active recreation programs in 2022 and beyond.

CPISRA INTERNATIONAL CONFERENCE



DSA partnered with the Cerebral Palsy International Sport and Recreation Association (CPISRA) to deliver the inaugural 2021 CPISRA International Conference on Physical Activity and Health for People with Cerebral Palsy or Acquired Brain Injury (aka the 2021 CPISRA International Conference). The Conference provided a forum

for knowledge exchange and enhance interaction between researchers, healthcare professionals, sporting experts, individuals and families to address the unique matters in the interdisciplinary area of adaptive physical activity and sport for individuals with cerebral palsy and acquired brain injury. The CPISRA International Conference was held in partnership with the University of Sydney Institute for Musculoskeletal Health, Cerebral Palsy Alliance, Cerebral Palsy Sport and Recreation Association and the Cerebral Palsy Foundation online from 8 - 11 December 2022.

Disability Sports Australia was proud to be the event host for this first of its kind international event and being able to facilitate important and meaningful conversations about sport and physical activity for people around the world with cerebral palsy and acquired brain injury. The event saw attendees from around the world participating in a number of sessions and workshops facilitated by world leading voices in this space.

Disability Sports Australia has continued to develop and utilise its digital channels to be a "one-stop shop" for information about sport and active recreation for people with disability. The DSA website houses an up to date database of thirty (30) sport and active recreation opportunities. Each sport listed on the website has key information about what the sport is, how to get involved, who can participate and the key contacts around the country. This will continue to grow as more opportunities and sports become available.

DSA has continued to use its social media channels to profile existing programs and opportunities with significant growth being made across all social media channels.

WHAT IS IMPACT & SHARED SERVICES?

Measure the impact of sport and active recreation for people with disability to drive program development, evaluation and advocacy.

RESEARCH & DATA

In 2021/22, DSA focused on improving the quality of data collection through its programs in order to measure the impact and behaviours around sport and active recreation.

Through the AISD program, DSA collected pre-event surveys from each participant. This survey focused on collecting the child's current participation in sport and recreation, access to equipment and funding and their interest level in future participation and specific sports. Key insights included:

With the implementation of the National Referral Hub in late 2021, data collection will form a key outcome of the success of the Hub, whilst also connecting these participants with their local sport and recreational activities.

In 2021/22, DSA is looking to expand this data collection as the AISD program rolls out nationally. DSA also continues to work with University partners to deliver and support quality research projects to better build understanding and capacity in the disability sports sector.

AUSTRALIAN SPORTING ALLIANCE FOR PEOPLE WITH A DISABILITY (ASAPD)



As part of the National Sport Plan (Sport 2030), the AUSTRALIAN SPORTING ALLIANCE FOR PEOPLE WITH A DISABILITY

As part of the National Sport Fiall (Sport 2030), the Australian Government committed to sport and physical activity becoming more accessible to people with disability. Since 2019, nine National Sporting Organisations for people with a Disability (NSODs) Organisations for people with a Disability (NSODs) have collaborated to create a collective vision to

represent the needs of individuals with disability, impairment, or limitation throughout Australia.

The NSODs formed a key peak agency for sport and physical activity for people with disability - the Australian Sporting Alliance for People with a Disability, ASAPD. Its vision is that all Australians have an opportunity to engage in sport and physical activity in a welcoming and inclusive environment.

The NSODs involved represent lead organisations whose participant numbers, members and volunteers involve millions of people across Australia, and include Blind Sports Australia, Deaf Sports Australia, Disability Sports Australia, Disabled Wintersport Australia, Paralympics Australia, Riding for the Disabled Association Australia, Special Olympics Australia, Sport Inclusion Australia and Transplant Australia.

The members' history is rich dating back to 1954, with a combined experience of more than 430 years and have countless examples of improving lives. The Australian Sports Commission has worked with the Alliance since its inception by providing funding and staffing support to enhance its development and sustainability.

IMPACT & SHARED SERVICES

Disability Sports Australia continues to work closely with the ASAPD with representation on the Oversight Committee and a number of key working groups.

The ASAPD, in partnership with the Australian Sports Commission, has achieved initial success:

- Developing a four-year strategic plan
- Developing a communications plan with joint ASAPD social media channels
- Identifying a clear plan for events and inclusion activities through to 2032 and beyond to ensure all of the people the nine Alliance groups represent have access to sport and opportunities
- Collectively lobbying and liaising with government departments: Health, NDIS/Disability and Sport to advocate for people with disability.
- Improved efficiencies between the agencies


DSA is looking forward to improving the Australian sporting landscape for people with disability in collaboration with the other eight NSOD's.






